I. Introduction

Since the BPG's proposal on the future political structure was published in 1986, there have been growing public interest and enquiries about the composition of its proposed Grand Electoral College (GEC). All the time, it is our opinion that the mechanism for structuring the Grand Electoral College should be determined by either a BLDC sub-group, or the Joint Liaison Group or by the Government concerned.

Hence the BPG has never had any intention of determining or publishing details of the constituents of each category within the Grand Electoral College. However, in view of popular requests for further details regarding the kind of constituents for the proposed Grand Electoral College, the BPG has recently compiled the following lists of examples for reference purpose. Those interested are requested to note the following principles when referring to the lists:

1. The list is published for the purpose of providing EXAMPLES to illustrate the possible composition and broad representativeness of the GEC proposal;

2. The authorities concerned will have to update the list of eligible bodies from time to time, in order to ensure wide and proper representation in the Grand Electoral College;

3. BPG believes that GEC should operate on the principle that certain organisations should be given more seats for their size of representation and significance, and the authorities at the time will be responsible for seat allocations;

4. BPG believes that representatives of various organisations should be elected by their members in a free and democratic manner;

5. No organisation that is eligible for representation may enrol in more than one sector; and

6. No individual may hold more than one seat in the GEC.

II. Criteria on selecting constituents

BPG believes that the selection of constituents for the various sectors should follow some broad principles already in practice in Hong Kong. The principles being employed by the Government in selecting functional constituencies should be used as general guiding principles in the composition of representatives for the GEC's eleven designated sectors. BPG therefore proposes the following general criteria for the selection of eligible bodies:

1. Well-recognised major organisations, associations, unions and institutions with a territory-wide coverage should be represented. The electoral rolls will comprise voting members of these organisations;

2. Electoral rolls of the professions should be based on either their membership lists or on the statutory registers of members. Consideration should be given to those organisations with well-established and recognised qualifications;

3. Small organisations not affiliated with an umbrella body should be registered under special electoral rolls for the various sectors to ensure wide and proper representation.

4. Professional bodies originally affiliated to overseas organisations should be included in the representation; consideration should be given to those which have no local substitutes, and are localised or are in the process of being localised.

5. Given Hong Kong's special character as an international trade and financial centre, the BPG suggests that organisations representing major foreign trade and economic interests in Hong Kong should form part of the GEC constituencies. However, delegates from these bodies should

satisfy the basic requirement of 'having ordinarily resided in Hong Kong for a continuous period of no less than seven years and having taken Hong Kong as their place of permanent residence'.

III. Proposed changes to seat allocations

Since publication of the GEC proposal, there have been suggestions that those public interests represented by Statutory and Permanent Non-Statutory Bodies are already being adequately covered by the other sectors. Therefore, the BPG proposes to abolish the representation to the GEC for this particular sector. It is suggested that the fifty seats originally allocated to the Statutory and Permanent Non-Statutory Bodies be re-allocated to the sectors of Labour, Professionals and Education. Ten of the seats should be transferred to Education, thus bringing its total number to thirty, and twenty each to Labour and the Professionals, thus bringing their respective total to eighty.

I. 簡介：

基本法諮詢委員會工商專業界諮委在一九八六年發表對未來香港特別行政區政府結構的建議後，很多市民對建議中的大選舉團的組合，感到很大的興趣。一直以來，我們認為產生大選舉團成員的方法應該由基本法起草委員會成立的一個小組、中英聯合聯絡小組、或是由當時的政府去釐定。

因此，工商專業界諮委從未有意圖去釐定或發表有關大選舉團每個界別的組合成員席位細節。但是，由於很多人士紛紛要求知道大選舉團組合成員的進一步資料，工商專業界諮委有見及此，最近輯成以下的舉例名單，以供各界參考。各位在參考舉例時請注意以下原則。

1. 發表該名單用意是提供例子，以顯示大選舉團的可能組合及廣泛代表性。
2. 有關當局需要不時審核名單所列合資格的團體，此舉是要確保大選舉團具備廣泛及適合的代表性。
3. 工商專業界諮委認為大選舉團的運作原則是：某些機構是應該給予多一些席位，原因是某些機構具有廣大的代表性和重要性。而當時的有關當局將負責席位的分配。
4. 工商專業界諮委認為各機構之代表應由他們的會員在自由民主的情況下經選舉產生。
5. 任何符合資格的團體均只能代表一個界別。
6. 任何人士均只能在大選舉團內佔有一個席位。

II. 大選舉團組合成員之選擇準則：

工商專業界諮委認為各界別的組合成員之選擇應沿用一些已在香港實施的大原則。在釐定大選舉團十一個界別的組合時，香港政府在選擇功能團體時所採納的原則應被用作總的指導原則。因此，工商專業界諮委建議下述數點，作為選擇符合資格團體的一般準則。

1. 獲確認之全港性主要團體，協會，工會，及機構應該在大選舉團內得到代表。選舉登記表將包含該等

團體的選舉成員。

2. 有關各專業的選舉登記表應以該專業之會員名單或法定之會員登記為基礎，組織良好及其資格獲得確認的團體應予優先考慮。
3. 規模細小而又不屬於聯合會的團體，應登記在另外一份為各界而訂的選舉登記表。此舉是要保證大選舉團能夠有廣泛及合適的代表性。
4. 附屬於海外機構的專業團體應該在大選舉團獲得代表。那些在香港不能被其他團體替代而又經已本地化或正進行本地化的團體，應予考慮。
5. 香港是一個國際性的貿易及金融中心，基於此一特點，工商專業界諮委建議那些在香港代表重大外資貿易和經濟利益的團體應成為大選舉團界別組成部份，但這些團體的代表應符合一個基本要求：即他們必須『以香港為永久居住地，且在香港連續居住至少七年』。

III. 席位分配更改的建議：

自大選舉團的建議發表後，一些意見認為法定及永久性非法定團體所代表之功能經已在其他的界別中得到充份的照顧。因此，工商專業界諮委建議在大選舉團中取消法定及永久性非法定團體這個界別的代表地位。而原先分配予這個界別的五個席位將要重新分配予勞工、專業人士及教育界三個界別。根據該項建議，教育界將會多分配十個席位，即由原先的二十個增加至三十個席位，而勞工界和專業人士界別將由原先的六十個席位，分別增加至八十個席位。
